- Construct access, excavate liner trench area and backfill 230 l.m.
- Haul, place, grade and compact liner base sand 7,700 m²
- Supply and install 60mil textured HDPE liner 13,000 m²
- Haul and place liner cover sand 14,700 m²
- Construct 140 l.m. leachate collection trench c/w 150mmØ perforated pipe and cleanout
- Supply and install geogrid 7,700 m²
- Construct leachate collection chamber L.S.
- Weld seams to existing liner 100 l.m.
- Liner edge protection c/w non-woven filter cloth and warning tape
